

Important Notice for Exhibitors intending to hand-carry Medical Equipment and Supplies

Exhibitors are strongly advised not to hand-carry medical equipment and supplies to Medical Fair Thailand 2025, as such items are regulated by The Food and Drug Administration (FDA), Ministry of Public Health, Thailand.

However if hand-carrying your exhibition goods is unavoidable, you must contact our Official Freight Forwarder - either APT Showfreight (Thailand) Limited or Schenker Singapore Pte Ltd, – well in advance to arrange the necessary import license. Their contact details are provided below.

To apply for an import license for temporary importation, the following documents are required:

1. Commercial Invoice and Packing List,
2. Brochures, catalogues or Photographs of the exhibits,
3. Brand, model number and serial number of the medical devices,
4. Country of origin for each item,
5. Flight details (ETA and ETD Bangkok)

All required documents must be submitted to the Official Freight Forwarder no later than 15 days prior to the first day of the exhibition. The forwarder will provide you with a quotation and, upon your confirmation, will issue an invoice. Full payment is required before the license application process begins. Please note that import license approval typically takes 5–7 working days.

Additionally, you are required to contact your Chamber of Commerce to arrange for an ATA Carnet for your hand-carried goods. A copy of the ATA Carnet must be sent to the Official Freight Forwarder as early as possible, and no later than your arrival in Bangkok. We strongly recommend that you plan to arrive in Bangkok at least two working days before the start of the exhibition.

Arrival Procedure at Bangkok Airport:

1. Upon collecting your luggage, proceed to the “RED” customs channel and declare your goods.
2. Customs officers will inspect your goods and issue a Cargo Receipt.
3. Present the Cargo Receipt and ATA Carnet to the Official Freight Forwarder’s on-site office whom you have pre-contact for import license application as soon as you arrive Bangkok.
4. Customs clearance will take approximately two full working days, after which your goods will be delivered to your exhibition stand.

Important Compliance Notice:

No goods are permitted to be sold, distributed, or given away during the exhibition.

All items brought into Thailand under temporary importation must be re-exported after the event.
